WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on November 10, 2020 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2021 and ending December 31, 2021 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

The tax levy presented in this budget of \$108,402, which is an increase of \$2,875 over the prior year. In addition, the 2021 tax rate will be 14.2 cents, which represents a 0.2 cent increase from 2020.

There were no changes to the budget other than the addition of a new cost of operations and maintenance line item for first responder expenses in the amount of \$2,000. In addition, the reduction in the appropriation for debt service interest of \$483 or 15.6% is in alignment with the amortization schedule.

4. Complete a brief statement on the impact the proposed Annual Budget will have on the Amount to be Raised by Taxation, the use of the Restricted and Unrestricted Fund Balance(s) and how they are complying with the Property Tax Levy Cap. If Unrestricted Fund Balance is reduced by more than 10%, explain the projected impact on the following year's budget.

The tax levy increased from \$105,527 to \$108,402, which was primarily for the purpose of funding the new appropriation of first responder expenses of \$2,000. While Unrestricted Fund Balance is projected to be reduced by \$22,325, representing a reduction greater than 10%, \$21,500 of this reduction is the result of the appropriation to increase the reserve for future capital outlay. Therefore, the reduction in Unrestricted Fund Balance is not expected to adversely impact the 2022 budget.
