Discussion Item:

1. 2018 appointment resolution 02-2018

The Township Committee reviewed Resolution No. 02-2018 and made the necessary appointments to titles, chairpersons, liaisons and member for the Township and all committees. This resolution will be considered for adoption on Tuesday, January 2, 2018 at the Reorganization meeting. Appointments of note are Veronica English to Secretary of Land Use Board, Denise Peterson will serve as Municipal Alliance Coordinator while Veronica English is training for the position, and Lisa Fisher was appointed to the Right to Know Coordinator position. The Township Animal Shelter was announced as a TBD due to R.S. Animal closing December 31, 2017 and the ongoing negotiations with Cumberland County SPCA to serve in this capacity. The position of Fire Subcode Official & Fire Inspector will be TBD until someone is found to fill the position. It was determined the all Township Committee members will serve as co-chairs for the Economic Develop Committee. The Green Team Committee will no longer be actively listed.

2. LUB 2018 appointments

Mr. Whildin stated he will work on the vacant positions for the Land Use Board which include the Alternate #1 position. It was discussed that former LUB secretary Lillian Johnson has expressed an interest in serving in this position. All LUB members whose terms expire December 31, 2017 were renewed to expire December 31, 2018.

Mr. Whildin will let the committee know and additional members can be made to the Land Use Board by resolution at a later date.
