



WHEREAS, the Annual Budget for the Maurice River Township District No. 2 for the fiscal year beginning January 1, 2015 and ending December 31, 2015 has been presented before the Board of Commissioners of the Maurice River Township Fire District No. 2 at its open public meeting of November 18, 2014; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et. seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$118,001, which includes amount to be raised by taxation of \$106,352 and Total Appropriations of \$118,001; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District No. 2 has taken into account the assessed valuation of taxable property in the Fire District No. 2.

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Maurice River Township Fire District No. 2, at an open public meeting held on November 18, 2014 that the Annual Budget, including appended Supplemental Schedules, of the Maurice River Township Fire District No. 2 for the fiscal year beginning January 1, 2015 and ending December 31, 2015 is hereby approved; and

Beginning with the 2008 budget and in accordance with PL 2007, c.62, there is a statutory Cap on the Tax Levy, which represents a 2% increase on the prior year tax levy, adjusted by certain exclusions and additions to the Cap. The tax levy presented in this budget is \$106,352, which is equal to the maximum allowable Cap. There will be no significant change in the 2015 Budget.
2. Complete a brief statement describing the impact the proposed Annual Budget will have on the Amount to be Raised by Taxation to support the district budget and on the Restricted and Unreserved Fund Balance(s). Explain increases or decreases in the tax rate and utilization of fund balances. **If unreserved fund balance is reduced by more than 10%, explain the projected impact on the following year's budget.**  
The tax rate will be 18.8 cents per \$100 in 2015, which is 1 cent higher than in 2014. Although unrestricted fund balance is reduced by more than 10%, we do not anticipate any significant impact on the 2016 budget, as sufficient funds remain available to support the operating needs of the District in the future.
